SALIENT FEATURES OF THE RECRUITMENT PROCESS ADOPTED FOR APPOINTMENT TO THE POST OF STENOGRAPHER GRADE-III (LEVEL 4 OF PAY MATRIX) (ADVERTISEMENT NO. 1/2019-R-III)

- (1) Bhabha Atomic Research Centre, Trombay, Mumbai initiated recruitment process to fill up the vacancies in BARC and the Constituent Units of DAE located in Mumbai, Tarapur for the post of Stenographer Grade.III in Group 'C' (Non-Gazetted) by Direct Recruitment. Accordingly, an abridged version of Advertisement No. 1/2019-R-III was published in Employment News on 09th February 2019 and other daily newspapers on 31.01.2019. The elaborate advertisement was also displayed on BARC website www.barc.gov.in and www.recruit.barc.gov.in with instructions to candidates to apply online. The last date for submission of online applications was 25.02.2019.
- (2) Candidates registered with Employment Exchange, Maharashtra web portal www.maharojgar.gov.in, were requested to apply on-line for the said post through this Centre's website www.recruit.barc.gov.in on or before 25.02.2019 i.e the last date for submission of online application.
- (3) To ascertain the genuineness of the candidates applied, the candidates were requested to submit a copy of their skill certificates (shorthand & typewriting) online. The last date for receipt of certificates was 30.06.2019. Thereafter, a provisional list of candidates based on the certificates submitted by them was uploaded with an instruction to report any discrepancy noticed latest by 25.10.2019. Consequently, this Centre received representations & after ascertaining their genuineness, a final list of candidates was uploaded including these candidates.
- (4) Consequent on discontinuation of interviews, the mode of selection for the post of Stenographer Gr.III is Level 1 Test (Objective Test) & Level 2 Test (Stenography Skill Test).
- (5) Level 1 Objective test (written examination) was conducted on 17.11.2019. After declaration of Level 1 results, on the same day, document verification of the candidates who qualified Level 1 examination was conducted. Stenography skill test of these candidates was conducted on 18.11.2019.

- 10% mistakes for GEN & OBC candidates; 15% mistakes for SC & ST candidates.
