FACTS

Vide RTI dt 18.5.13, appellant had sought information on 4 points relating to his request for conversion from CPF to Pension Scheme which was denied.

2. PIO BARC Mumbai vide letter dt 26.7.13, provided a copy of BARC ID note dt 5.7.2006 along with list of 36 technical personnel who were converted from CPF to pension scheme. PIOs at BARC Tarapur and RMP Mysore were asked to furnish information pertaining to employees working in their units directly to the appellant.

3. PIO BARC Trombay vide letter dt 31.7.13 denied the information u/s 8(1)(j).

4. An appeal was filed on 23.8.13.

5. AA vide order dt 12.9.13, upheld the decision of the PIO.

6. Submissions made by the appellant and public authority were heard. Appellant submitted that while Mysore has provided the information, BARC Tarapur and Mumbai have denied the information u/s 8(1)(j).

DECISION

7. The Commission concurs with the decision of the public authority in denying copy of the service book pages. We however, direct PIO to provide to the appellant the information sought at query no. 2 and 3 of his RTI within fifteen days from date of receipt of the order.

The appeal is disposed of.


