Tenders should be sealed and submitted in a cover after indicating name of work, tender no. on the cover.
3. Tender will be kept valid for **60 (Sixty) days** from the Last date of closing of submission of tender.
4. On acceptance of the tender, the name of the accredited representative(s) of the contractor who would be responsible for taking instructions from the Engineer-In-charge shall be communicated to the Engineer-In-charge.
5. The entire work shall be guaranteed for a period of 12 months from the date of completion of work.
6. The department reserves the right to accept the whole or only part of the tender and the tenderer shall be bound to perform the same at the rates quoted.
7. Your quotation shall be submitted with breakup of applicable GST. GST shall be payable by the contractor and BARC will not entertain any claim whatsoever in this respect.
8. Please note that 2% income tax and cess as applicable shall be deducted from the bill paid to you.
9. Please note that 2% GST on TDS shall be deducted from the bill paid to you, in case contract value is more than 2.5 Lakhs.
