# Annexure-1

Detail specifications regarding the supply and installation of the stainless Steel (SS-304) plate (Quantity: one)

- 1. Plate (quantity: one) must be as per the dimensions mentioned in the Drawing.
- 2. Plate has to be in single piece without wielding.
- 3. All dimensions in the Drawing are in mm and scale-1:1.
- 4. General tolerances shall be On length up to 300 mm- +/-2.0 mm; Above
  300 mm & including 2000 mm- +/-5.0 mm, Over 2000 mm- +/-8.0 mm.
- 5. Straightness and flatness of the base plate should be maintained.
- 6. Surface finish should be maintained within 50-100 microns.
- 7. All burrs should be removed.
- 8. All sharp corners & edges should be rounded off.
- 9. Supplier should provide lifting hooks for the movement of the plate and the hooks must be removed after the installation.
- 10. Physical movement and installation of the base plate at the workplace will be carried out by the supplier with proper safety protocols.
- 11.Supplier will provide guarantee period 12 months from the date of supply against any manufacturing defects.
