- Quotation shall reach us on or before <u>22/02/2023</u> by Speed Post/Courier Only
- On top left corner of the envelope please indicate Quotation For – CNC Fabrication and Assembly of SS304, Al-7075 and Acrylic components for high precision measurements, and supply of required accessories: Due Date <u>22/02/2023</u>
- Price to be specfied strictly as per template provided in Annexure-II.
- Overwriting, scratching etc. must be avoided in the quotation. Rewriting the whole figure shall carry out any alteration in the figure. The authorised person from the firm shall countersign such figure.
- The delivery period mentioned in the quotation shall be strictly adhered to. If the contractor fails to supply and secure extension of delivery date before effecting delivery of the supply against the contract, acceptance of such item by the purchaser will in no way prejudice the right of the purchaser to levy liquidated damage nor will it be entitled to the contractor for payment of statutory levies that comes into force after the expiry of the delivery date.
- Minimum Guarantee / Warranty period of the materials shall be one year.
- Supplier shall mention clearly the PAN /TAN no. on quotation.
- GST number shall be clearly mentioned on Quotation
- All the charges and taxes shall be mentioned clearly.

 - ii. Advance Stamped Receipt
 - iii. Bank Account No, Bank and Branch name with IFSC code.
 - iv. Undertaking stating that GST has been promptly deposited with the authorities
- (3) It may be noted that:
 - i. Income tax @2% will be deducted from your bill.
 - ii. TDS(under GST) will be deducted as applicable from your bill of taxable goods and/or services, where the total value of such supply exceeds 2.50lakh.

Scope of Work

<u>CNC Fabrication and Assembly of SS304, Al-7075 and Acrylic components for high precision measurements,</u> and supply of required accessories.

Note:

- All the parts must be fabricated from single piece only (without involving any welded parts) and must be done in CNC only. For any doubt, kindly contact: (Contact Person: Shri. Rahulnath PP, 0891-2832142, rahulnathpp@barc.gov.in or Shri. Subhrajit Guin, 0891-2832144, <u>sguin@barc.gov.in</u>).
- (2) To periodically check the progress of work, inspection may be carried out by our team, at the vendor's manufacturing site. This will be preceded by a 2-days prior notice, from our end to the vendor.
- (3) Pre-Dispatch Inspection shall be carried out once the fabrication is completed and all the materials are ready.
- (4) The Vendor should not dispatch the materials before the Pre-Dispatch Inspection is completed.

Brief Description of Work:

The above work consists of the following

- (1) Fabrication of each component from single piece only, with CNC only.
- (2) Assembly of the components to form fully-functional assemblies.
- (3) Supply of the above assembly along with Accessories Required.

- 5. Single order will be placed for the entire work and no partial work is permitted.
- 6. Delivery should be completed within 30 working days from the commencement of the work order.
- 7. Any delay which is attributable to the contractor is liable for penalty @ $\frac{1}{2}$ % per week (max 5%) to be imposed on the contractor.
- 8. The vendor should accept & provide the material as per the description & specifications mentioned. Those who fail to provide the acceptance for the material their quotation technically will not be accepted *Subhrajit Guin*
