- **4. Printed Letter Head**: Quotation should be furnished in party's letter head duly signed and stamped by the concerned person.
- **5.** Validity of the Offer: Validity of the offer shall be 90 days from date of opening of quotation.
- 6. Guarantee: Vendor shall have to give guarantee of the quality and workmanship of work done for the period of 12 months from the date of completion of the work.
- 7. The work shall be subject to inspection by our Engineers at site. The work completion shall be subject to approval by our Engineers.
- 8. Offer of Firm: Offer of those firms, who do not submit their quotation as per the details given in the technical specification and incomplete quotations in any respect shall not be considered.
- **9.** The department reserves right to extend the date of opening the quotations and accept or reject any or all quotation without assigning any reason.
- 10. Payment Terms: Accounts Division BARC Mumbai-400085 shall make full and final payment only after submission of the satisfactory work completion certificate issued from the undersigned, bill, guarantee certificate, delivery challan and advanced stamped receipt. No advance is admissible.
- 11.Income Tax Recovery Clause: Income tax @ 2% and surcharge @ 15% will be deducted from the bill.
- **12.** If any of the employee, consultant, or partner of the company is an Ex BARC employee, the same must be stated in the quotation clearly.
- **13.Penalty:** Any delay which attributable to the contractor is liable for penalty @ 0.5 % per week (max 5 %) to be imposed on contractor.
- 14. GST/PAN Number: Quotation shall consist of GST and PAN number of the firm.
- **15.**Only Electric supply 415 volts, 3 phase, 50 c/s & water will be supplied by BARC at free of cost.
- **16.Safety Rule:** The vendor shall follow all the safety procedures as per the normal industrial practice during the execution of the job at site. Any mishap occurring during the work due to unsafe workmanship shall be the vendor's liabilities. Security and transportation rules at BARC, Trombay premises shall be strictly followed.
- 17. The contractor should ensure that the scrap generated at the work place during the course of the work should be carried safely to the designated place at BARC. The job completion certificate will be issued only after clearing of all such materials from the work premises of BARC.

- 18. Housekeeping at the work place during the course of the work is the sole responsibility of the contractor. The contractor should get site clearance certificate from the BSMO of the division before submitting bill.
- 19. Industrial safety undertaking: Vender shall submit industrial safety undertaking as per attached format and carry out job hazard analysis of the contract work to identify hazards involved in each step of the activity and bring out control measures pertaining to hazard and submit the report to Local Safety Committee, HWD for the same before starting the work.

20. Security rule:

- (b) Security rules and transport rules at BARC, Trombay premises shall be strictly followed.
- (b) Laborers below 18 years of age shall be not allowed to work at site.
