<u>Description of Work</u>: "Annual Service contract of periodic cleaning & servicing of various ACVE & utility equipment's such as Air handling unit, Qty- 8 no's, Fresh air filter banks with 340 no's. of HDPE filters, supply & return air grills-300 no's etc at WIP, WMD, BARC, Trombay".

The tenderer may contact on telephone No. 2559 1136 to make necessary security permit for site visit to understand the detailed scope of work & issuance of tender enquiry.

Sealed quotations should be submitted only through registered post/speed post through Indian Postal Service to following address:-

Sealed envelope should indicate i) Name of the work ii) Tender notice reference /enquiry number, iii) Name & address of firm etc. Otherwise the tender /quotation shall be summarily rejected.

Note: The enquiry will be issued to firm those who are having similar kind of work experience and firm need to produce documented evidence for the same. Application for collecting enquiries to be obtained from Supdt (Mech), WMF, with prior appointment.

Enquiry shall be issued to the eligible contractors from <u>04.07.2022 to 18.07.2022</u> between 10:00 hrs to 16:00 hrs on all working days.

Last date of submission of sealed quotation is **19.07.2022 by 12.00 hrs**. The sealed quotation will be opened on **20.07.2022** at 14:00 hrs. in the office of authorized tender opening officer, WMD/WIP, BARC.

BARC reserves right to reject any or all the tenders/application without assigning any reason thereof.

### **General instructions:**

- 1. The contractor's Engineers, supervisors workmen etc. should have valid PVC (Police verification certificate) to work inside BARC.
- 2. Taxes if any shall be mentioned separately. Your quotations are to be in printed letter head / quotation format which should consist of GST Registration Number, PAN Number of the firm etc.
- 3. Quotations that are received in computer generated form are to be construed as invalid and rejected.
- 4. The Payment shall be made quarterly on submission of the quarterly bills. Payment will be made as per Government procedure after the job is completed satisfactory in all respects and has been approved by the officer supervising the job. Payment shall be made only on satisfactory completion of work and on production of bill in duplicate, advance stamped receipt, guaranty/warranty certificates stores, service reports, ECS details & Pan card copy. In general after submission of all the papers, it takes about a month period for releasing the payment. As per standard practice followed in BARC Income tax @ 2%, surcharge on IT and educational cess at 2% on IT and SC will be deducted from the bill amount
