# **General Terms and Conditions**

## 1. Quality surveillance, inspection and inspection report

- 1.0 All work covered by the inspections shall be subjected to quality surveillance by the purchaser or his authorized representatives for which purpose the fabricator shall allow access at all reasonable times during manufacture to The premises in which the work is being carried out.
- 1.1 The drawings and or tooling involved.
- 1.2 Gauges, instruments etc. required for inspecting the work.
- 1.3 Components found unsatisfactory as to workmanship or material shall be removed by the fabricator and replaced by the components which is satisfactory.

### 2. Raw Material

2.1 Raw Material for all the components and hardware will be provided by the supplier.

#### 3. Sub Contract

The fabricator shall not sub-contract any or all the work without written consent from the purchaser. The fabricator shall be responsible to the purchaser for all of the sub-contractor of the fabricator, if at all allowed by the purchaser.

### 4. Taxes

5. GST @ 5% against undertaking from the supplier.

### 6. Payment

- 6.1 Payment will be made only after satisfactory completion of work and on production of Invoice with details of location of supply, separate tax components, GSTN and PAN, receipt cum issue voucher from stores, advance stamped receipt, and guarantee certificate (4 nos.) and Bank details.
- 6.2 Advance/ part payment or against delivery cannot be made.
- 6.3 It may be noted that Income Tax at 2% and surcharge on IT at the rate applicable will be deducted from the bill.
