Vendor/Contractor coming for briefing and getting hard copy of Tender Enquiry/document should take prior appointment with the undersigned on 2559 6027 (or, Shri. Pankaj Damke on 2559 6355) on any working day from 11:00 hrs to 17:00 hrs.

Following criteria is required for acceptance of Tender Enquiry by the Vendor/Contractor:

- Vendor/Contactor should have pre-cleared Security Vetting of his company/Firm as per BARC Security rules.
- Proposed technical persons and supervisors of the company/ Firm should have valid PVC not expiring during the tender period (i.e., from the date of issue of this enquiry till completion of job after getting work order). No excuse thereafter getting work order will be entertained.

- c) Vendor/Contractor coming for discussion and getting tender enquiry should have valid pass of BARC. No entry permit will be made by BARC.
- d) Vendor/Contractor and his work force should have experience of working in BARC premises related to above mentioned work/jobs. (Document proof is to be submitted)
- e) The past experience of the firm in similar nature in BARC/ DAE shall be made available with work order copy and satisfactory completion certificate from the user. Also the list of ongoing jobs inside BARC premises with expected completion period shall be provided.
- f) Technical persons proposed by the vendor should be well experienced in hazardous chemical handling, running lab equipment such as ICP, ED-XRF, spectrophotometer and carrying out precision works such as titration, solvent extraction, reagent preparation etc (similar job experience)
- g) Technical persons proposed by the vendor for execution of job in this tender should have proper and required PPE (personal protective equipment) and arrangement for all above shall be made by Vendor/Contractor only.
- h) Technical persons proposed by the vendor must have valid COVID-19 final vaccination certificates for execution of the job.
