
Name of work : Relocation of spent fuel chopper development unit by systematic dismantling and cutting and removal of auxiliary steel structure from fabrication workshop.

Description of the Work: Removal of hydraulic oil from barrels, Disconnection of Electrical and Instrumentation cables. Systematic dismantling of Fuel Chopper components, De-mounting of auxiliary mild steel structures, segregation of components, packaging, shifting to identified place by EIC.

- c) Sealed quotation will be opened on 17/02/2018 at 14.00 hrs. in the office of Head, FRD, BARC, Trombay, Mumbai -400 085.
- d) Sealed quotation should be submitted only by registered post/speed post through Indian postal service only.
- e) Sealed envelope should indicate NIT Ref. No. with date and due date of tender opening. Tender shall be addressed to:

- f) Work shall be completed within 04 calendar months from release of work order.
- g) The offer shall be valid for a period of 60 days from the date of opening and the quoted amount shall remain firm during the period of execution.
- h) Quotations should be in printed letter head, signed by the proprietor or authorized person with company seal. Quotations should consist of GST & PAN Number etc of the firm. Quotations that are received in computer- generated form are to be construed as invalid and rejected.
- i) The full payment will be made as per Government procedure after the job is completed satisfactorily in all respects and has been approved by the EIC/competent authority.
- j) The contactor's engineers, supervisors, laborers etc must have valid PVC (Police Verification Certificate) to work inside the BARC.
- k) The person coming at site for Pre-bid meeting should intimate the office two days in advance along with Name and Designation for making entry permit and should hold valid authorization letter and photo identification like driving license/passport/election card/Aadhar card identity card issued by employer etc. for security regulation
