Tender Notice No: **BARC/HUES/NG-28/30/2022-2023**

Sealed tenders are hereby invited in single part on behalf of the President of India for the work of

“AMC for maintaining premises of workshop and associated facilities which also include collection of machine scrap & debris, segregation of scrap, disposal of scrap to designated area, housekeeping & cosmetic maintenance, lifting-lugging, loading-unloading of heavy jobs

The location of premises are a) ED&DD Workshop b) Selected rooms of RLG c) PRAFPUL-2 Workshop d) Nitrogen plant area at RLG” From eligible contractors.

- 1 Tenders are to be on the printed forms of Bhabha Atomic Research Centre, Hot Lab Utility & Engg. Services Section, Trombay, which can be had on proving the ability to do such jobs and on payment of Rs. 500 /- (non-returnable) in cash.
- 2 Tender documents will be available at the office of CE & Head, Hot Lab Utility & Engg. Services Section, Radiological Labs, Bhabha Atomic Research Centre, North Site, Trombay, MUMBAI – 400 085 on any working day between 10.00 hrs. to 16.00 hrs. from **09/01/2023 to 13/01/2023**. Application for tender document shall be received in his office by 16.00 hrs. on **12/01/2023**.
- 3 Tenderers should submit a copy of PAN, VAT, GST no, Solvency Certificate of a Nationalized Bank / Scheduled Bank for a minimum of **Rs 1.90 Lakhs** and should not be older than one year from the date of opening of tender , annual financial turnover of last 5 years ending 31st March 2021. & List of manpower having valid Police Verification Certificate (PVC) should be furnished along with tender application.
- 4 Tenders should be placed in sealed covers superscribed with tender no. and name of work and which will be received by the CE & Head, Hot Lab Utility & Engg. Services Section, Radiological Labs, Bhabha Atomic Research Centre, North Site, Trombay, Mumbai up to 14.30 hrs. on **19-01-2023** and the same will be opened in presence of AAO, TSD at 15.00 hrs. on **19/01/23** in the presence of such tenderers who desire to attend.
- 5 Earnest Money Deposit in the form of Demand Draft/Deposit at Call/FDR for the amount shown below in favor of Accounts Officer, B.A.R.C., should be furnished along with the tender. **Tenders not accompanied with valid EMD are liable for rejection.** EMD of requisite value shall be submitted in a separate cover and the tender bid shall only be opened after confirming the submission of EMD in the specified form.
- 6 The contractor whose tender is accepted will be required to furnish by way of security deposit for the due fulfillment of his contract, such sum as will amount to 2.5% of the tendered value of work. In addition, the contractor shall be required to deposit an amount equal to 3 % of the tendered value of the contract as Performance Security before commencement of the work but not later than stipulated date of commencement. This period can be extended further at the written request of the contractor for a maximum period of 15 days with late fee @ 0.1% per day of Performance Guarantee amount.

- 7 The Security Deposit will be collected by deductions @ 2.5 % of the gross amount of the running bill of the contractors till the sum will amount to 2.5% of the tendered value of work. The Security deposit will also be accepted in the form of Governments Securities, Fixed deposit Receipts of Scheduled Bank and Nationalised Bank. These shall be endorsed in favor of the Accounts Officer, BARC, Mumbai.
- 8 If the successful tenderer fails to furnish the prescribed performance guarantee on or before stipulated dates of commencement or in the approved extended period, the Department (BARC) shall without prejudice to any other right or remedy, be at liberty to **penalize** with late fee @ 0.1% per day for a maximum period of 15 days of Performance Guarantee amount.
- 9 Following **Taxes are deductible**:
- The contractor should be registered under GST and GST shall mean Goods and Service Tax-Central, State and Inter State.
 - GST or any other tax applicable in respect of inputs procured by the contractor for this contract shall be payable by the contractor and Government will not entertain any claim whatsoever in respect of the same. However , component of GST at the time of supply of service (as provided in CGST Act, 2017) provided by the contract shall be varied if different from that applicable on the last date of receipt of tender including extension if any.
 - Labour welfare cess @1% of gross value of work done shall be recovered from each bill paid to the contractor.
 - Income tax and cess and GST @ 2% or as applicable shall be deducted from each bill paid to the contractor.
 - Contractor should be registered under EPF & ESIC as per law or if Department asks for, then contractor shall pay EPF & ESIC of contract workers to concerned Department and it will be reimbursed to him by the Department after satisfying that it has been actually and genuinely paid by the contractor. The bidder should not consider EPF & ESIC in his rates.
 - Any other taxes/cess as per Government directives shall be deducted from each bill paid to the contractor from time to time.
- 10 The time allowed for carrying out this work is Twelve 250 days **(12) months**.
- 11 Tender shall be kept valid for **90 (Ninety)** days from the Last date of submission of tenders
- 12 The acceptance of the tender will rest with the CE & Head, Hot Lab Utility & Engg. Services Section, who does not bind himself to accept the lowest tender and reserves to himself the right to reject any or all tenders without assigning any reasons whatsoever.
- 13 Tenders which do not fulfill all or any of the above conditions and incomplete in any respect are liable to be summarily rejected.
