- 7. Validity of offer : Price should be valid throughout the contract period. Minimum validity period of vendor's offer shall be 60 days from the due date.
- 8. Offer of firm : Offer of those firms, who do not submit their quotation as per the details given in the technical specification and incomplete quotation in any respect shall not be considered.
- 9. Work Completion Period : 3 months after confirmation of order.
- 10. Minor alteration/addition of the job as per site requirement shall be accepted by the vendor without adding any extra cost.
- 11. Penalty : Penalty at the rate of 1/2% per week of the total cost (max10%) or as applicable will be charged if the job is not completed within the specified time without valid reasons, as applicable.
