1) Material: Copper-ETP

NOTE:

The following points must be taken care of, or else item will not be accepted.

- 1) The item should be fabricated as per drawing attached (Annexure-I).
- 2) Electrical Discharge Machining (EDM) process is to be used for the 0.5 mm slit cutting along the shaper for 70 mm, as indicated in the drawing. The items have to be delivered within 5 weeks at the user's site, i.e Pulsed Power & Electromagnetics Division (PP&EMD), Bhabha Atomic Research Centre (BARC), Visakhapatnam-531011.
- 3) Tolerance on drawing dimensions allowed is \pm 1 % except for slit. Slit being a critical dimension, \pm 100 micron tolerance is allowed. Any fault or deviation in item from detailed drawing will not be accepted. Incase found, the party must take the items from user's site to its place and provide a fresh piece against the faulty piece.
- 4) Party must first supply 01 No. of the fabricated item and ensure the dimensional compatibility of the item to our existing system at BARC (V)-Atchutapuram. If compatibility is achieved party can then fabricate the rest no.s and supply the same within the delivery period as will be mentioned within work order. Minor modifications must be incorporated by the party without extra cost. At time of supply of items party has to confirm compatibility check on existing system of all the pieces at BARC(V) site, incase any defect found in any piece party must replace the defective piece with a new one.
