Description of work :
Handling & Processing of Radioactive materials, cleaning/decontamination and maintaining of Radioactive plant area and miscellaneous associated work at UED, MG, BARC, Trombay, Mumbai site.

The terms and conditions are given below:

Hard copy of Tender Enquiry will be given to the Vendor/Contractor by hand on all working days from 14:00 hrs to 16:00 hrs till the due date and time mentioned above after briefing the scope of work/job in Detail and other plant site requirements under the Tender.

Vendor/Contractor coming for briefing and getting hard copy of Tender Enquiry/document should take prior appointment with undersigned on 25594837/ 25594550 on all working days from 11:00 hrs to 17:00 hrs .

Following criteria is required for acceptance of Tender Enquiry by the Vendor/Contractor:

- a) Vendor/Contractor should have pre-cleared Security Vetting of his company/Firm as per BARC Security rules.

- b) All workers/labors of the Vendor's/Contractor's Company/Firm should have valid PVC (for minimum 10 persons) not expiring during the tender period (i.e., from the date of issue of this enquiry till completion of job after getting work order). No excuse thereafter getting work order will be entertained.
- c) Vendor/Contractor coming for discussion and getting tender enquiry should have valid pass of BARC. No TEP will be made by BARC.
- d) Vendor/Contractor and his work force should have experience of working in BARC premises related to above mentioned jobs.
- e) The past experience of the firm in similar nature in BARC/DAE shall be made available with work order copy and satisfactory completion certificate from the user. Also the list of ongoing jobs inside BARC premises with expected completion period shall be provided.
- f) Workers/labors given by the vendor should be well experienced in Radio-Active & Inactive Material Handling and Decontamination jobs (similar job experience).
- g) All workers/labors of the Vendor/Contractor for execution of job in this tender should have proper and required PPE (personal protective equipment) and arrangement for all above shall be made by Vendor/Contractor only.
- h) Vendor/Contractor should submit copies of Medical Fitness Certificate of his workers/labors given by him for execution of the job in this tender.
- i) Medical Insurance Policy (for minimum 05 persons) and COVID -19 final vaccination certificate of all the workers/labors is necessary for execution of the job.
- j) Vendor/Contractor coming for briefing and getting Tender Enquiry for detailed work **should mandatory bring and show following documents (original or copy)-**
 - i. Medical insurance Policy (for minimum 05 persons) & COVID-19 final vaccination certificate of all the workers/labors
 - ii. Valid PVC of workers/labors (for minimum 10 persons)
 - iii. Similar job experience proof (work order copy and satisfactory completion certificate from the user side)
 - iv. Security Vetting of his company
