Quotations are invited on behalf of Head, UED in sealed envelope for installation and testing of new panel for operation at UMP in UED, BARC.

1. Scope of works: -

- Installation, End Termination, Testing and Commissioning of power and control panels. The job involves grouting of panels with all necessary accessories like nut bolts, anchor fastener etc. Proper earthing should be provided to the panel if required earthing Patti to be laid by vendor (approx 10 meters).
- Installation of 1 panels of 2100x300x1875 mm
 - End termination of power and control panel with required glands, lugs, ferrules, name plate etc
