- 1. Scope of work-as per annexure-A
- 2. Eligibility:
 - a) Tenderer should have the experience of successfully completed similar works during last Seven years. And during these period, the Tenderer should have worked in any government organisation at least once. Copies of work orders of these contracts and job completion certificates from the competent authority should be submitted.
 - b) The prospective contractor for the above work should quote for 3 skilled workers with minimum educational qualification of 10+2 and computer background and also ensure that those employees possess necessary Police Verification Certificate (PVC), for entry in BARC premises issued by Office of Commissioner of Police, Mumbai/Navi - Mumbai.
- The contract may be extended for a further period of <u>One Year</u> and on the same terms & conditions subject to satisfactory performance of the vendor and mutual consent of both the parties.
- 4. Taxes and excise duties shall be quoted separately.
- 5. Please note that quotation should be in quotation format given in Annexure-A on Company Letter Head and should have sales tax registration number registered with local ST authority/CST authority, PAN number, service tax registration number. The Quotations should be legibly hand written or type written and should have the seal of the Company, full address of the bidder, Signature of the Proprietor of the firm. The tenderer should quote in figures as well as in words the amount tendered by him. Any discrepancy between the figures and words, the amount written in words will prevail. Alterations / overwriting, unless legibly attested by the tenderer, shall disqualify the tenders.

- 11. The acceptance of the tender rests upon the undersigned with a right to reject or to accept any or all tenders without assigning any reason.
- 12. Any other statutory levy imposed by the Govt. of India from time to time will be paid extra on demand with adequate proof thereof
- 13. The Contractor shall pay the minimum wages to the labours as prescribed by Government of India from time to time
- 14. The Contractor, on acceptance of letter of intent, shall within 15 days arrange to deposit an amount equal to 3% of in the form of Bank Guarantee/Fixed Deposit receipts of Scheduled Bank.

The PBG shall be refundable to the Contractor after satisfactory completion of the contract based on certification done by BARC after deducting penalty, if any, imposed on him.

If the Contractor delays, neglect or refuses to render and provide services in accordance with the terms of this agreement, the BARC shall be within its legal right to terminate the contract and forfeit the PBG and cancel the services of the Contractor by giving written notice of not less that 2 weeks to the Contractor.

16. BARC shall have the right, any time during the duration of the contract to suspend, terminate and cancel the contract.
