5. Offers sent by telegram, telex, fax or e-mail will **not** be considered.
6. All taxes should be mentioned clearly.
7. Good & Services Tax @ 5%. The goods proposed to be fabricated on this work order are meant for research purpose of Research Institution under Department of Atomic Energy and are exempt from payment of GST in terms of Notification No. 47/2017 integrated tax (rate) dated 14.11.2017 issued by Ministry of Finance, Department of Revenue of Government of India. In the event of order, the Purchaser will make available the GST exemption certificate duly signed by the authorized officer in the Department of Atomic Energy
8. Quotation should be in the printed letter head /quotation format which should consist of Sales Tax Registration Number, PAN Number of the firm, Service Registration Number, etc.
9. **Quotation shall be signed by proprietor or authorized person and affix company seal.**
10. Computer generated quotation form will not be accepted.
