

3. Taxes and duties etc. shall be quoted separately.



Annexure-II

General Terms and Conditions

A. Qualification Criteria:

The bidder must have a previous work experience of the similar nature, i.e. Fabrication, Supply, Installation, Inspection, Warranty & delivery of accessory as per annexure- 1.

B. Warranty:

The supplier should provide warranty of 1 year for the installation work and items above mentioned in Annexure-I.

C. Work Period:

Duration of the work is **60 working days** from the date of issuance of work order.

Price: Inclusive of free and safe delivery at our site. Price once quoted & accepted shall remain final.

Taxes: GST as applicable may be specified separately.

: Income Tax @ 2% as applicable at the time of payment will be deducted from your bill.

: For payment above Rs.2, 00,000=00, work contract tax @2% or as applicable shall also be deducted.

Excise Duty: Nil, *Excise duty is not payable by the Purchaser. Exemption certificate will be provided.

Octroi Duty: Nil. Exemption certificate will be provided for the end product on specific request as applicable.

Delivery : The work should be start as soon as work order issued.

Payment : Payment will be made only after satisfactory completion of work and on submission of printed Delivery Challan, Bill cum Invoice in Triplicate and an Advanced Stamped Receipt for the amount of the bill. Payment exceeding Rs 20,000/- are subject to Income Tax Deduction at source, Surcharge, Education Cess on Income tax etc as applicable under Income Tax Act will be deducted from your bill.

Penalty Clause: Any delay which is attributed to the contractor is liable for penalty @ ½ % per week (max. 5%) to be imposed on the contractor.

Extension clause:

In case any extension is required due to unavoidable reason, please send a request before expiry of work order justifying the delay. However, granting extension is sole discretion of Head, TPD.

Note : 1. Quotations, challans, invoice, receipt etc should be in printed form only. These should consist of GST Registration Number registered with local ST authority / CST authority, PAN Number of the firm, Service Tax Registration Number, etc.

Quality Surveillance, Inspection and Inspection report: All work covered by the specifications shall be subject to quality surveillance by the purchaser or his authorised

representatives for which purpose the fabricator shall allow access at all reasonable times during manufacture to :

1. The premises in which work is being carried out.
2. The drawings and / or tooling involved.
3. Gauges, instruments etc. required for inspecting the work.

Inspection and tests shall be carried out by the fabricator as per the requirements detailed in the drawings and these specifications. Components found unsatisfactory as to workmanship or material shall be removed by fabricator and replaced by components, which are satisfactory. The finished components shall not be despatched prior to our approval.

Confidentiality: No party shall disclose any information to any third party concerning the matters under this contract generally. In particular, any information identified as “Proprietary” in nature shall be kept strictly confidential by the receiving party and shall not be disclosed to any third party without the prior written consent of the original disclosing party.

The clause shall apply to the sub-contractors, advisers, or employees engaged by a party with equal force.

1. “Restricted information” categories under Section 18 of the Atomic Energy Act 1962 and “Official Secrets” under Section 5 of the Official Secrets Act 1923:

Any contravention of the above-mentioned provisions by any contractor, sub-contractor, consultant, adviser or the employees of the contractor will invite penal consequences under the aforesaid legislation.

2. Prohibition against use of BARC’s name without permission for publicity purposes:

The contractor, sub-contractor, consultant, adviser or the employees engaged by the contractor shall not use BARC’s name for any publicity purpose through any public media like, Press, Radio, T.V., and Internet without the written approval of BARC***Excise Duty Clause** as mentioned vide circular No. *BARC/Accts/GSS/97/983* dated 14.7.97 is quoted below:

"Since the goods to be supplied against this work order meant for research purpose of a Research Institute under the Department of Atomic Energy, No Excise Duty is payable for the goods covered by this work order.

The Indenter shall make available the excise duty exemption certificate to avail of the Excise Duty exemption

well before the delivery date stipulated in work order. It shall however be the responsibility of the contractor

also to ensure that they dispatch the goods only after getting excise duty exemption certificate from the indenter”
