Sealed quotations are invited by for and on behalf of President of India by Supdt, SWM, WMF, Trombay, BARC, Mumbai for the approved and eligible contractor having adequate works experience of similar nature at RSMS, BARC.

Description of Work:- Maintenance and operational support for functioning of the Try butyl Phosphate system, Potential Radioactive waste collection sump system at SWM, WMD, BARC, Trombay

Enquiry to be displayed from 25/03/2022 to 05/04/2022 between 10.00 to 16.00 Hrs on all working days. Last date for submission of the sealed quotation will be 07/04/2022 up to 12.00 hrs. The sealed quotations will be opened on the same day at 14.00 hrs. in Divisional office, *NRG*, BARC, Trombay.

Terms and Conditions

- 1. Police Verification Certificates and medical fitness certificate from registered medical officers shall be required for supervisor and working persons at site.
- 2. Enquiry will be issued to eligible tenderer after receipt and scrutiny of application for issue of quotation. Quotation without prior application and scrutiny will not be considered.
- 3. Rates should be in lump sum. One Job (Basic amount & GST mention separately).
- 4. As the work is in potentially radioactive areas, work is to be carried out as per health physicist guidelines. Before quoting for work, it is required to visit the site to understand the detailed scope of work. Working experience in Radioactive plant in any DAE units is mandatory.
- 5. The Interested tenderer should visit the site before quoting rates, the tenderer may contact on telephone no. 022-25592184 to make necessary security permit for submission of application.
- 6. Sealed quotation should be submitted only through speed post or registered post through Indian Postal Service addressed to Shri S.M.Bhandare (SA/E), SWM, WMD, BARC, Trombay, Mumbai 400 085.
- 7. You are requested to submit your quotation in sealed envelope for the above mentioned job. The reference tender notice no. given above should be clearly mentioned on the sealed envelope.
- 8. Your offer shall be valid for minimum 30 days from the date of opening and quoted price shall remain firm during the period of execution of the order.
- 9. Taxes, duties, levies, other charges etc., if any, shall be clearly mentioned.
- 10.Payment will be made only once after completion of the work. It may also be noted that income tax @2% and surcharge on IT as applicable it shall be deducted from your bill.
- 11. Superintendent (SWM)WMD, WMFT, BARC, Trombay, reserves right to accept/ reject any or all tenders/ quotation without assigning any reasons thereof.

Earnest Money Deposit:

EMD is not to be submitted. Bid – Security declaration form (Annexure- II) is to be filled and submitted before opening of the tender. It shall be noted that non-compliance of Bid Security Declaration would amount to suspension from bidding for a period of one year from the publication of this NIT.

- 2. <u>Vendor Evaluation Criteria</u>: Firms meeting the following criteria should only quote for the tenders. Quotations of the firms not fulfilling these requirements will be rejected.
- 3. The work involves break down maintenance/ preventive maintenance /system operation/ decontamination/ loading / unloading , site clearance by shifting of materials to scrap point within SMW, complex, BARC, Trombay. Therefore, the vendors should have domain expertise of similar works.
- 3.1The work is to be carried out as per health physicist guidelines. Working experience in Radioactive plant in RSMS is mandatory, vendors and his man power should have adequate knowledge.
- 3.2As several activities are to be carried out at site i.e., at BARC, Trombay in a given stipulated time frame; hence, deployment of necessary skilled Man power at BARC, Trombay is an essential requirement. Vendors having readily available skilled man-power with valid police verification certificates should only participate in the bidding.
- 3.3 For the technical qualification vendor shall submit the copies of Work Order/Purchase Order of indicating previous experience of execution of similar types of works.
- 4. Subsequent to scrutiny of submitted documents, Vendor's premises may be visited by Group of Officials to ascertain the submitted information. Vendor shall provide full co-operation during scrutiny.
- 5.COVID related guidelines applicable to the contractor for the site works at BARC as published on BARC website or as issued by Engineer in Charge shall be scrupulously followed during the execution of work.
- 6.Any deviation from specification shall be clearly mentioned in your offer.
- 7. The quotation shall be printed only on letter head and GST number as well as any other prevailing Tax Registration Number registered with local, state/Central authority, PAN Number of the firm, Service Tax Registration Number etc should be mentioned on it.
- 8.Quotations that are received in computer generated form are to be considered as invalid and will be rejected.
- 9.Income tax @ prevailing rate at the time of execution of work and applicable surcharge on Income Tax as applicable & education cess on IT & SC as applicable will be deducted from the bill. Tax as applicable on GST will also be deducted from bill.
- **10.**Similarly, claims raised by the firms are also to be in Printed Invoice formats consisting of the above Registration Numbers.
- 11.It is necessary to mention Taxes Registration Numbers clearly in the quotation, without which the offers will not be considered.
- 12. The bids sent by any other mode (e.g. manual, courier etc) shall be rejected without assigning any reasons as per terms and conditions of Accounts, BARC.
 - 13. The offer shall be valid for minimum period of 90 days from the date of opening and quoted price shall remain firm during the period of execution of the order.

- 14.Only those Vendors quoting for all the works mentioned as per the enclosed BOQ will only be considered. Part offer will be rejected.
- 15.Offers will be evaluated on overall total cost basis hence it is mandatory for bidders to consider entire work and quote accordingly.
- 16.Undertaking: The vendor shall give undertaking stating that he has understood the entire scope of work as well as other associated security/safety and other general requirements and he will complete the entire work as per BOQ in time as per the completion period of the work order.
- 17. The Payment will be made as per Government procedure after the job is completed satisfactorily in all respects and has been approved by the officer supervising the job. Payment shall be made only on satisfactory completion of work, removal of debris/waste arising out of the work carried out from site and on production of bill in duplicate, advance stamped receipt, guarantee / warranty certificates, stores receiving voucher duly signed by ASO (if applicable), No Demand Certificate from Security. In general, after submission of all the papers mentioned in work order, it takes about a month period for releasing the payment, as per standard practice followed in BARC.

18. Additional Clauses:

- I. Any bidder from a country which shares a land border with India will be eligible to bid in this tender only if the bidder is registered with the Competent Authority. Certificate for the same attached as Annexure III(a) has to be signed and submitted by bidder before opening of the tender.
- II. "Bidder" (including the term 'tender', 'consultant' or 'service provider' in certain contexts) means any person or affirm or company, including any member of a consortium or joint venture (that is an association of several persons, or firms or companies), every artificial juridical person not falling in any of the descriptions of bidders stated hereinbefore, including any agency branch or officer controlled by such person, participation in a procurement process.
- III. "Bidder from a country which shares a land border with India" for the purpose of this Order means :
 - a) An entity incorporated, established or registered in such a country; or
 - b)A subsidiary of an entity incorporated, established or registered in such a country; or
 - c)An entity substantially controlled through entities incorporated, established or registered in such a country; or
 - d)An entity whose beneficial owner is situated in such a country; or
 - e)An Indian (or other) agent of such an entity; or
 - f)A natural person who is a citizen of such a country; or
 - g)A consortium or joint venture where any member of the consortium of joint venture falls under any of the above.
- IV. The beneficial owner for the purpose of (III) above will be as under:
 - 1)In case of a company or Limited Liability Partnership, the beneficial owner is the natural person(s)., who whether act5ing alone or together, or through one or more juridical person, has a controlling ownership interest or who exercises control through other means.

Explanation: -

- a) "Controlling ownership interest" means ownership of or entitlement to more that twenty-five percent of shares or capital or profits of the company.
- b) "Control shall include the right to appoint majority of the directors or to control the management or policy decisions including by virtue of their shareholding or management rights or shareholders agreements or voting agreements.

- 2)In case of a partnership firm, the beneficial owner is the natural person(s) who, whether acting alone or together, or through one or more juridical person, has ownership of entitlement to more than fifteen percent of capital or profits of the partnership;
- 3)In case of an unincorporated association or body of individuals, the beneficial owner is the natural person(s), who, whether acting alone or together, or through one or more juridical person, has ownership of or entitlement to more than fifteen percent of the property or capital or profits of such association or body of individuals,
- 4) Where no natural person is identified under (1) or (2) or (3) above, the beneficial owner is the relevant natural person who holds the position of senior managing official;
- 5)In case of trust, the identification of beneficial owner(s) shall include identification of the author of the trust, the trustee, the beneficiaries with fifteen percent or more interest in the trust and any other natural person exercising ultimate effective control over the trust through a chain of control or ownership.
- V.An Agent is a person employed to do any act for another, or to represent another in dealings with third person.
- VI. The successful bidder shall not be allowed to subcontract works to any contractor from a country which shares a land border with India unless such contractor is registered with the Competent Authority. Certificate for the same attached as Annexure III(b) has to be signed and submitted by bidder before opening of the tender.
- VII. Eligible source countries: Any Bidder, from a country which shares a land border with India must comply to the Order (Public Procurement No.1) & Order (Public Procurement No. 2) issued by Public Procurement Division, Department of Expenditure, ministry of Finance, Government of India vide F. No. 6/18/2019-PPD dated 23.07.2020 and its addendum from time to time. Also, the bidder shall provide a certificate as per Proforma given 'Annexure III(c)'. If such declaration or certificate is found to be false or to be incorrect at any time of submission of Bid or after awarding the Contract, then the said Contract will be terminated, along with such other actions as may be permissible under the relevant law of India.

A) Installation Practices:

- 1. The contractor shall use proper electrical plug/sockets. Use of loose wiring will not be permitted.
- 2. The contractor shall use all safety gears like helmets, safety belts, safety shoes etc. and follow safe installation practices. All the safety precautions shall be meticulously followed, the instructions given by Engr. In Charge & Safety Coordinator from time to time shall be abided.
- 3. Installation shall be neat and workmanship shall be of excellent quality.
- 4. The Contractor should supply and install all the fixtures, which may not be specifically mentioned in above, but necessary for the completeness of the work, without any additional cost.
- 5. All the accessories such as clamps, MS boxes, MS Angles, nuts bolts and screws, fixers, ravel plugs, etc. should be supplied by the Contractor.
- 6. The contractor shall be responsible for any loss or damage during transportation, handling and storage of materials and/or any components.
- 7. The installation of the above work should be as per the guidance of Engineer-in-charge of work.

B) Inspection & Testing:

- 1.All the items / materials shall be inspected at Contractor's end/Sourcing Agency before dispatch. Functional tests shall be repeated at site after installation & commissioning, but before final acceptance.
- 2.Inspection and defects rectifications: -Any defects observed or detected during inspection shall be rectified by the contractor at his own cost and in procedure acceptable to Engineer-in-charge/dept. engineers at no extra cost.

C) Working Conditions:

The contractor shall arrange all equipment and personnel required for the successful completion of the work. Contractor shall clean the site after work and dispose the waste generated properly. Contractor shall stick to the schedule given and complete the work before work order expiry.

Safety and security rules: --

a)	Police verification certificate is required for all workers and supervisor deployed at the site.
b)	Security rules and transport rules at BARC, Trombay premises shall be strictly followed.
c)	Labors under 18 years shall not be allowed to work at site.
d)	Department shall not be responsible for any injury caused to contractor workforce due to any reason / unsafe working procedures followed by his personnel while working at site.
e)	Covid 19 Guide lines issued by BARC/ Statuary Authorities shall be scrupulously followed by Contractor and his persons.

Note: Contractor shall have readily available deployable work force with valid PVC.

- 1. Supplier shall bring all requisite mounting accessories, fittings, connectors /adapters etc for associated works.
- 2. All handling equipment, scaffoldings, tools and tackles, ladders, other machines, safety belts, welding machines etc required for the erection work shall be arranged by the Contractor.
- 3. All the clauses of BARC Safety Manual should be followed at any time during the work. The Manual is available on BARC website for reference.
- 4. The vendor should arrange transport of materials required for carrying out the work in advance i.e. prior to starting of the field jobs. Please note materials /tools etc entry to the site & their exits is subjected to security checks & procedure laid down by BARC security sections & shall be strictly followed during the site execution. Electricity and Water will be provided free of cost for the above work.
- 5. The vendor shall arrange adequate accident insurance coverage of his personnel. BARC shall not be responsible for any liability arising out of any accident / injury caused to vendor's personal while executing the work.
- 6. To the extent possible the work shall be carried during the normal working hours i.e. 9.30 A.M to 5.30 P.M. Monday to Friday. Prior permission will be required to work on holidays and beyond office hours on working days & holidays.
- 7. This work involves working in restricted area with security restrictions on entry of workers, working time etc.
- 8. All the workers and their supervisors need to have police verification done and cleared.

9. Contractor shall at his own cost, make arrangements for transport of his personnel, materials tools etc. to and from the site.
