Quotation shall be complete in all respects with regard to specifications, validity of offer etc., and must reach via speed post / courier to the above mentioned address on or before 06.05.2022, by 12.00 hrs.

The sealed quotation will be opened on the same day at 14:00 hrs. in the office of AAO, WORKS - II, CC, BARC, TROMBAY, MUMBAI - 400085.

Following criteria is required for acceptance of tender enquiry by the vendor/contractor:

- 1. The main envelope carrying the quotation should contain the technical bid and the price bid in two separate sealed envelopes inside it. The technical bid should contain duly-filled 'Technical Compliance Sheet'. It may please be noted that evasive or ambiguous response in the technical bid will be treated as non-compliance.
- 2. <u>It may also be noted that the price bids of those firms whose technical bid is acceptable and suitable will only be considered for the commercial evaluation.</u>
- 3. <u>Bidders shall have experience of completing at least three similar works in the past five</u> years and provide the respective work completion certificate/PO copy.
- 4. Validity of offer shall be valid for minimum 30 days from the date of quotation opening.
- 5. Vendors/contractors coming for discussion and getting tender enquiry should have valid pass of BARC. No TEP will be made by BARC.
- 6. Worker/labourers given by the vendor/contractor should be well experienced in the mentioned iob.
- Vendor/contractor and his work force should have experience of working in Radioactive area of BARC
- 8. All materials, tools, equipments are to be provided by the contractor.
- 9. Work shall be completed within 90 days release work order.
- 10. Your quotations are to be in printed letter head / quotation format which should consist of GST Registration Number & PAN Number of the firm.
- 11. Quotations that are received in computer generated form are to be construed as invalid and rejected.
