Online tender in two parts i.e. Part A –Techno-commercial Bid and Part B – Financial/Price Bid are hereby invited through **e-Tendering mode** on behalf of the President of India by Head, Research Reactor Maintenance Division, Bhabha Atomic Research Centre, Trombay, Mumbai-400 085 for the following work from eligible contractors on approved list of CPWD, MES, Railways, Public Sector Undertakings of Central or State Governments / Central Autonomous bodies or those contractors having adequate experience and capabilities to execute similar works of such magnitude in Department of Atomic Energy (DAE).

II. INITIAL ELIGIBILITY CRITERIA:

2. i) The bidder shall be compliant to the Public Procurement (**Preference to Make in India**), Order 2017 (as amended from time to time) issued by Department for Promotion of Industry and Internal Trade (DPIIT), Ministry of Commerce and Industry. Also bidder must submit undertaking along with bid for local content of.... % offered in subject tender.
- ii) Only “Class-I local supplier” as defined in Public Procurement (Preference to Make in India), Order 2017, are eligible to participate for subject tender.
- iii) The bidder should have the following:

- (a) Registration in Appropriate Class of Contractors, if any
 - (b) Bank Solvency Certificate of a Nationalized Bank/Scheduled Bank for a minimum of **Rs. 5,03,640/- (40% of estimated cost)** and should not be older than one year from the date of opening of tender.
 - (c) Average annual financial turnover in respect of works as applicable of the firm during last 3 immediate consecutive financial years ending 31st March of the previous financial year shall not be less than the tender value i.e. **Rs. 12,59,100/-**. This should be duly audited by a registered Chartered Accountant.
 - (d) The firm should not have incurred loss in more than two years during the last five years ending 31st March 2022.
 - (e) The firm shall not be under court receivership or under liquidation.
 - (f) Performance certificate.
 - (g) Construction Plant, Machinery, equipment & other infrastructure facilities to complete the work in time.
 - (h) Required Technical Staff.
 - (i) Valid GST Registration Certificate.
 - (j) Permanent Account Number (PAN).
3. The bidder should have satisfactorily completed (based on the certification of performance by client of the works) **3 (Three)** similar works each of value not less than **Rs. 5,03,640/-** (40% of estimated cost put to tender) or **2 (Two)** similar works each of value not less than **Rs. 7,55,460/-** (60% of estimated cost put to tender) or **1 (One)** similar work of value not less than **Rs 10,07,280/-** (80% of estimated cost put to tender) during the last 7 (Seven) years ending on the last day of the month previous to the one in which the tenders are invited.

For the purpose, "cost of work" shall mean gross value of the completed work including the cost of materials supplied by the Govt./Client, but excluding those supplied free of cost. For the purpose of clause Similar Works means "**means "General electrical works including electrical wiring, cabling, lighting, installation of panels etc**"The similar works should have been executed in India.

4. The value of executed works shall be brought to the current costing level by enhancing the actual value of work at simple rate of 7% per annum, calculated from the date of completion to last date of submission of tenders.
5. The bidding capacity of the contractor applicable should be equal to or more than the estimated cost of the work put to tender. The bidding capacity shall be worked out by the following formula:

$$\text{Bidding Capacity} = [A \times N \times 2] - B, \text{ Where,}$$

A = Maximum turnover in construction works executed in any one year during the last five years taking into account the completed as well as works in progress.

N= Number of years prescribed for completion of work for which bids have been invited.

B= Value of existing commitments and ongoing works to be completed during the period of completion of work for which bids have been invited.

6. Bidder should be a registered firm in India. Joint Ventures and or Consortiums are not acceptable.

III. INFORMATION:

7. Tender document is prepared in two parts viz. Part 'A' (Techno-commercial Bid) and Part 'B' (Financial/Price Bid). Part 'A' consists of Techno-commercial Bid viz. Section I - Notice Inviting e-Tender (English & Hindi versions), Section II - Form of Agreement & General Rules and Directions / guidance for the Contractors, Memorandum, Section III – General Conditions of Contract, Additional conditions, Section IV - Special Instructions to Tenderers, Appendix 'A' - Bid Security (Bank Guarantee), Appendix 'B' - Form of BG bond for performance security, Appendix 'C'- Safety Instructions for Working In Radioactive Area (Appendices 3, 6, 7A & 7B of AERB), Section V - Technical specifications, Section VI – E-tender Technical bid (uploaded separately), Section VII - Schedule 'A' (Schedule of Materials to be supplied by Department), , Annexure 'A'–Statement of men and machinery, and Annexure 'B' – Schedules 'A' to 'F'. Part 'B' (Financial/Price bid) consists of Schedule 'B' - Schedule of Quantities. All the above documents will form part of Agreement after award of work to the successful bidder.

OBTAINING OF STANDARD DOCUMENTS: Prospective Bidders or general public can see and download free of cost **PDF format** of the above documents from website www.barc.gov.in **Tenders and NITs** **Other Information**.

IV. Guidelines for e-Tendering in CPPP website:

To participate in the tendering process on the CPP Portal, Prospective Bidders require a valid Class III Digital Signature Certificates. All the documents related to the eligibility criteria of tender should be submitted electronically through CPPP portal only. The instructions given below are meant to assist the bidders in registering on the CPP Portal, prepare their bids in accordance with the requirements and submitting their bids online on the CPP Portal.

More information useful for submitting online bids on the CPP Portal may be obtained at: <https://eprocure.gov.in/eprocure/app>.

8. Registration:

- (i) Bidders are required to enroll on the e-Procurement module of the Central Public Procurement Portal (URL:<https://eprocure.gov.in/eprocure/app>) by clicking on the link **“Online Bidder Enrollment”** on the CPP Portal which is free of charge.
- (ii) As part of the enrolment process, the bidders will be required to choose a unique username and assign a password for their accounts.
- (iii) Bidders are advised to register their valid email address and mobile numbers as part of the registration process. These would be used for any communication from the CPP Portal.
- (iv) Upon enrolment, the bidders will be required to register their valid Digital Signature Certificate (Class III Certificates with signing key usage) issued by any Certifying Authority recognized by CCA India (e.g., Sify / nCode / eMudhra etc.), with their profile.
- (v) Only one valid DSC should be registered by a bidder. Please note that the bidders are responsible to ensure that they do not lend their DSC's to others which may lead to misuse.
- (vi) Bidder then logs in to the site through the secured log-in by entering their user ID / password and the password of the DSC /e-Token.

9. Searching for Tender Documents:

- (i) There are various search options built in the CPP Portal, to facilitate bidders to search active tenders by several parameters. These parameters could include Tender ID, Organization Name, Location, Date, Value, etc. There is also an option of advanced search for tenders, wherein the

bidders may combine a number of search parameters such as Organization Name, Form of Contract, Location, Date, Other keywords etc. to search for a tender published on the CPP Portal.

- (ii) Once the bidders have selected the tenders they are interested in, they may download the required documents / tender schedules. These tenders can be moved to the respective "My Tender's folder. This would enable the CPP Portal to intimate the bidders through SMS/email in case, there is any corrigendum issued to the tender document.
- (iii) The bidder should make a note of the unique Tender ID assigned to each tender, in case, they want to obtain any clarification / help from the Helpdesk.

10. Preparation of Bids:

- (i) Bidder should take into account any corrigendum published on the tender document before submitting their bids.
- (ii) Please go through the tender advertisement and the tender document carefully to understand the documents required to be submitted as part of the bid. Please note the number of covers in 5 which the bid documents have to be submitted, the number of documents - including the names and content of each of the document that need to be submitted. Any deviations from these may lead to rejection of the bid.
- (iii) Bidder, in advance, should get ready the bid documents to be submitted as indicated in the tender document / schedule and generally, they can be in PDF / XLS / RAR / DWF/ JPG formats. Bid documents may be scanned with 100 dpi with black and white option which helps in reducing size of the scanned document.
- (iv) To avoid the time and effort required in uploading the same set of standard documents which are required to be submitted as a part of every bid, a provision of uploading such standard documents (e.g., PAN card copy, annual reports, auditor certificates etc.) has been provided to the bidders. Bidders can use "My Space" or "Other Important Documents" area available to them to upload such documents. These documents may be directly submitted from the "MySpace" area while submitting a bid, and need not be uploaded again and again. This will lead to a reduction in the time required for bid submission process.

Note: *My Documents space is only a repository given to the Bidders to ease the uploading process. If Bidder has uploaded his Documents in My Documents space, this does not automatically ensure these Documents being part of Technical Bid.*

11. Submission of Bids:

- (i) Bids shall be submitted online only at CPPP website: <https://eprocure.gov.in/eprocure/app>
- (ii) Bidder should log into the site well in advance for bid submission so that they can upload the bid in time i.e., on or before the bid submission time. Bidder will be responsible for any delay due to other issues.
- (iii) The bidder has to digitally sign and upload the required bid documents one by one as indicated in the tender document.
- (iv) Bidder has to select the payment option as "offline" to pay the EMD as applicable and enter details of the instrument.
- (v) Bidder should prepare the EMD as per the instructions specified in the tender document as applicable. The original should be posted/couriered/given in person to the concerned official, latest by the last date of bid submission or as specified in the tender documents. The details of the DD/any other accepted instrument, physically sent, should tally with the details available in the scanned copy and the data entered during bid submission time. Otherwise, the uploaded bid will be rejected.
- (vi) **The agency shall download the pre bid clarification if any for the work and upload the same (scanned copy) duly signed and sealed. The revised documents (if any) shall be uploaded in e-tender portal.**

- (vii) Bidders are requested to note that they should necessarily submit their financial bids in the format provided and no other format is acceptable. **If the price bid has been given as a standard BoQ format with the tender document, then the same is to be downloaded and to be filled by all the bidders.** Bidders are required to download the BoQ file, open it and complete the SKY BLUE coloured (unprotected) cells with their respective financial quotes and other details (such as name of the bidder). No other cells should be changed. Once the details have been completed, the bidder should save it and submit it online, without changing the filename. If the BoQ file is found to be modified by the bidder, the bid will be rejected.
- (viii) Tenderers are advised to upload their documents well in advance, to avoid last minutes rush on the server or complications in uploading. BARC, in any case, shall not be held responsible for any type of difficulties during uploading the documents including server and technical problems whatsoever.
- (ix) Bid documents may be scanned with 100 dpi with black and white option which helps in reducing size of the scanned document.
- (x) The server time (which is displayed on the bidders" dashboard) will be considered as the standard time for referencing the deadlines for submission of the bids by the bidders, opening of bids etc. The bidders should follow this time during bid submission.
- (xi) Submission of the tender documents after the due date and time (including extended period) shall not be permitted.
- (xii) All the documents being submitted by the bidders would be encrypted using PKI encryption techniques to ensure the secrecy of the data. The data entered cannot be viewed by unauthorized persons until the time of bid opening. The confidentiality of the bids is maintained using the secured Socket Layer 128 bit encryption technology. Data storage encryption of sensitive fields is done. Any bid document that is uploaded to the server is subjected to symmetric encryption using a system generated symmetric key. Further this key is subjected to asymmetric encryption using buyers/bid opener's public keys. **Overall, the uploaded tender documents become readable only after the tender opening by the authorized bid openers.**
- (xiii) Upon the successful and timely submission of bids (i.e., after Clicking "Freeze Bid Submission" in the portal), the portal will give a successful bid submission message & a bid summary will be displayed with the bid no. and the date & time of submission of the bid with all other relevant details.
- (xiv) The bid summary has to be printed and kept as an acknowledgement of the submission of the bid. This acknowledgement may be used as an entry pass for any bid opening meetings.
- (xv) Intending Bidders are advised to visit this website regularly till closing date of submission to keep themselves updated as any change/ modification in the tender will be intimated through this website only by corrigendum / addendum/ amendment.

12. Assistance to Bidders:

- (i) Any queries relating to the tender document and the terms and conditions contained therein should be addressed to the Tender Inviting Authority for a tender or the relevant contact person indicated in the tender.
- (ii) Any queries relating to the process of online bid submission or queries relating to CPP Portal in general may be directed to the 24x7 CPP Portal Helpdesk.

CONDITIONS:

13. After opening of Part 'A' of tender, Head, RRMD/Chief Engineer shall constitute a technical evaluation committee which will first verify the online credentials submitted by the bidder with respect to their eligibility for the work and if required, will visit selected worksites of ongoing/completed works of the tenderers to evaluate the capability of the tenderers based on the following.

- a) Financial capability and their turnover during the last 5 years.
- b) Technical capabilities of the company in the light of subject work.
- c) Nature of works executed by the tenderer during last 7 years.
- d) Organizational structure of the company.
- e) Necessary Resource required by company to carry out the subject work.

- f) Time & quality consciousness.
- g) Tendency of the company with regard to making extraneous claims and disputes.
- h) Site planning ability.
- i) Tendency of the company to award the work on back to back / subletting.

14. As per the security procedure in force in Bhabha Atomic Research Centre, the successful bidder shall be vetted by the Security Section of BARC before award of the work.
15. No modifications in the tender shall be allowed after opening Part 'A'.
16. Tenders with any condition including conditional rebate shall be rejected. However, tenders with unconditional rebate will be accepted.
17. **If any information furnished by the applicant is found to be incorrect at a later stage, they shall be liable to be debarred from tendering / taking up works in BARC in future forever. Also, if such a violation comes to the notice of Department before start of work, the Engineer-in-charge shall be free to forfeit the entire amount of EMD and Performance Guarantee.**
18. The time allowed for carrying out the work will be reckoned from the 15th day after date of written order to commence the work or from the first day of handing over of the site, whichever is later, in accordance with the phasing, if any, indicated in the tender documents.
19. Tender will be kept valid for **180 (One Hundred Eighty) days** from the last date of closing of online submission of tenders.
20. In case the last date of receipt of original document towards Tender Processing Fee, EMD and opening of tender are declared as holiday, the respective date shall be treated as postponed to the next working day, correspondingly.
21. Earnest Money in Original to be submitted in the form of Fixed Deposit Receipt/Demand Draft/Banker's Cheque/Pay Order of a Scheduled Bank issued in favour of "Accounts Officer, BARC, Mumbai". **A part of Earnest Money is acceptable in the form of Bank Guarantee also. In such case minimum 50% of the Earnest Money or Rs. 20.00 Lakhs, whichever is less, shall be in the form prescribed above and balance can be accepted in the form of Bank Guarantee issued by a Scheduled Bank as per Appendix 'A' of Tender document.** Further, Receipt of Hard copy of EMD shall be submitted at afore-mentioned place given in Sr No 1, sealed, superscribed envelope mentioning name of work and NIT number.
- Further, original EMD and Tender acceptance documents should be submitted preferably in person. **It should not be put in drop box at gate.** However, documents sent by post or courier will also be considered provided the same is received within due date & time. The documents may be hand delivered at North Gate to Engineer-in-charge of RRDPD, BARC, Trombay, Mumbai - 400085. Submission of EMD is compulsory on or before the due date & time, otherwise Tenders are liable to be rejected and will not be processed further.
22. The contractor whose offer/quotation is accepted will be required to furnish by way of security deposit for the due fulfillment of his contract, such sum as will amount to **2.5%** (Two point five Percent) of the tendered value of work. In addition, the contractor shall be required to deposit an amount equal to 3% of the tendered value of the contract as performance Security. Time allowed for submission of Performance Guarantee shall be 15 days from the date of issue of letter of acceptance. This period can be further extended at the written request of the contractor by EIC for a maximum period ranging from 1 to 15 days with late fee @0.1% per day of performance Guarantee amount. Performance Security of

3% can also be accepted in the form of Bank guarantees (in case Performance Security exceeds Rs. 1.00 Lakh), fixed deposit receipts of Scheduled Banks or in the form of Government Securities.

- 23.** The Security Deposit will be collected by deducting @ 2.5% of the gross amount of the running bill of the contractor till the total security deposit recovered becomes 2.5% of the tendered value of work. The Security deposit will also be accepted in the form of Government Securities, Fixed Deposit Receipts of Scheduled Bank and Nationalized Bank. These shall be endorsed in favour of the Accounts Officer, BARC, Mumbai. **Earnest Money deposit of successful bidder shall be returned back/refunded on receipt of Performance Security Deposit**, however in case Performance Security Deposit is in the form of Bank Guarantee, Earnest Money Deposit will be released subsequent to confirmation of verification of Bank Guarantee from the issuing Bank.
- 24.** If the successful tenderer, fails to furnish the prescribed performance guarantee on or before stipulated dates of commencement, the department (BARC) shall without prejudice to any other right or remedy, be at liberty to forfeit the said earnest money absolutely.
- 25.** The acceptance of tender shall rest with department which does not bind itself to accept the lowest tender and reserves rights to itself the authority to reject any or all of the tenders received, without assigning any reason. All tenders in which any of the prescribed conditions are not fulfilled or incomplete (in any respect) are liable to be rejected.
- 26.** Canvassing in connection with tenders is strictly prohibited and the tenders submitted by the contractors who resort to canvassing will be liable for rejection.
- 27. On acceptance of the tender, the name of the accredited representative(s) of the contractor who would be responsible for taking instructions from the Engineer-In-charge shall be communicated to the Engineer-In-charge.**
- 28.** The department reserves the right to accept the whole or only part of the tender and the tenderer shall be bound to perform the same at the rates quoted.

29. Levy/Taxes Payable by Contractor

- (i) **Goods & Services Tax (GST)** or any other tax applicable in respect of **inputs procured by the Contractor** for this contract shall be payable by the Contractor and Government will not entertain any claim whatsoever in respect of the same. However, **component of GST at time of supply of service (as provided in CGST Act 2017) provided by the contract shall be varied if different from that applicable on the last date of receipt of tender including extension if any.**
- (ii) The contractor should be registered under Goods and Services Tax (GST). The GST as applicable on the work shall be paid by the contractor to the concerned tax authorities.
- (iii) The quoted rate shall be inclusive of GST and shall be payable by the contractor and BARC will not entertain any claim whatsoever in this respect.
- (iv) 2%TDS on GST, Labour welfare CESS @1% of gross value of work done shall be recovered from each bill paid to the contractor.
- (v) Income tax and CESS as applicable shall be deducted from each bill paid to the contractor.
- (vi) Contractor should be registered under EPF & ESIC and as per law or if department asks for then contractor shall pay EPF and ESIC of contract workers to concerned department and it will be

reimbursed to him by the department after getting satisfied that it has been actually and genuinely paid by the contractor. The bidder should not consider EPF and ESIC in his rates.

Contractors shall comply provisions of the EPF Act, 1952 in respect of all the eligible employees / workers/ labours and submit the documentary proof regularly with every RA Bill.

(vii) Any other taxes/CESS as per government directives shall be deducted from each bill paid to the contractor from time to time.

30. If any tenderer withdraws his tender within the validity period and before award of work whichever is earlier or make any modifications in the terms and conditions of the tender which are not acceptable **to the department, then the Government shall without prejudice to any right or remedy to suspend the bidder for one year from the date of issue of suspension order.**

31. After award of work to the successful bidder, the contractor shall submit time schedule & cash flow statement for approval of Competent Authority which will form part of Agreement.

32. The Successful bidder whose tender is accepted will be required to obtain Police Verification Certificate (PVC) issued by Special Branch of Police at his own cost and responsibility for all his workmen i.e., Engineers, Supervisors and Labours to work in BARC, Trombay, Mumbai and should quote accordingly. The PVC will be valid for three years.

BIDDERS MAY PLEASE NOTE THAT ONLY POLICE VERIFICATION CERTIFICATE (PVC) HOLDER WORKMEN WILL BE ALLOWED TO ENTER BARC PREMISES AND SHOULD QUOTE ACCORDINGLY.

In case of receipt of any adverse charter and antecedent remarks/notification against the Contractor/Company/Firm/Proprietor and/or his contract Personnel, consequent to the security vetting, BARC reserves absolute right to terminate the contract forthwith without assigning reason/show cause notice. Under the circumstance the Contractor will have no right to claim good any losses/liability that may be incurred as consequence to the above action initiated by BARC. Department also reserves right to forfeit in part/full performance security and/or security deposit in possession of the Government for failure on the part of the contractor to abide/adhere to the Security instruction issued by DAE/BARC from time to time.

INSTRUCTIONS:

33. The contractor should be registered with <https://eprocure.gov.in/eprocure/app>. Those contractors not registered on the website mentioned above, are required to get registered.

34. The intending bidder must have valid class-III digital signature key to purchase / Download of Tender Document (excel/word formats).

35. Tenders will be received online up to time & date as mentioned in the NIT details above. Part A will be opened on the time & date as mentioned in the NIT details above. The EMD will be checked first. If found in order, Part A will be opened.
