4. A copy of the valid license under Food Safety & Standards Authority of India (FSSAI)-2006 or 2011 for running a Canteen/ Tea Pantry.

OR


Necessary license/permission from the state Government / Municipal Corporation / Public Health Department for running of eatery.

5. The prospective Contractor for the above Canteen / Tea Pantry should ensure that those employees possess necessary Police Verification Certificate, for entry in BARC premises issued by Office of Commissioner of Police, Mumbai / Navi Mumbai/Thane before commencement of the contract.
6. Demand draft Rs. 1,250/- towards Earnest Money Deposit to be drawn in favour of Pay & Accounts Officer, BARC.
7. The application duly signed by contractor on each pages in token of acceptance of rates approved by BARC
8. Check List/ Declaration in prescribed format.
