Information sought and background of the case:

Vide RTI application dated 25.10.2013; the appellant sought information under 3 points regarding duration for which service engineer was called to attend PLC based DCS software related issues since year 2005. CPIO vide letter dated 12.11.2013, expressed inability to furnish information as not maintained being beyond the record retention schedule. The appellant preferred first appeal. FAA vide order dated 06.12.2013 upheld the reply of CPIO. Feeling aggrieved the appellant approached the Commission.

Relevant facts emerging during hearing:

The appellant is absent despite notice. The CPIO is present and heard. He states that the information sought pertained to year 2005. He apprises the Commission that records/details of outside visitors are preserved only for 2

years and as such the same could not be made available to appellant since the RTI application was made in year 2013.

The appellant is not present to canvass his case.

Decision:

After hearing the respondent and perusal of record, the Commission finds no infirmity in the decision taken by the CPIO & FAA.

The appeal is disposed of accordingly.
