

DUTIES AND RESPONSIBILITIES OF IFA, BARC :-

- 1. Rendering of financial advice within the field of financial powers delegated to Director, BARC who is the Head of the Department (HOD).
- 2. Financial Concurrence for various proposals/sanctions/orders issued by Director, BARC
- 3. Formulation and monitoring of Sector-wise budget (i.e. Capital (R&D, I&M and Power) and Revenue) of BARC
- 4. Rendering financial advisory services after due administrative approval but before incurring expenditure out of Consolidated Fund of India in various Capital Projects, Revenue Expenditure and Strategic Projects of national importance
- 5. Concurrence and vetting of the project proposals
- 6. Project Monitoring, with special reference to periodical physical and financial progress
- 7. Settlement of Statutory and Internal Inspection draft audit paras etc.
- 8. Rendering financial advisory services as a member of various Committees (Administrative and Procurement matters) constituted by Director, BARC and various committees including Tender Committees constituted by the Secretary, DAE
- 9. Monitoring of Development & Works contracts and joint collaborative agreements/arrangements involving financial concurrence, budget formulation and expenditure monitoring
- 10. Rendering financial advice to other constituent units under aegis of DAE wherever such responsibilities are entrusted such as HBNI, BRIT, GCNEP
- 11. Nominated as a finance member in international joint venture scientific
