**ORDER**

1. The appellant filed RTI application dated 30.06.2017 under the Right to Information Act, 2005 (RTI Act) before the Central Public Information Officer (CPIO), Bhabha Atomic Research Centre, Mumbai seeking information on three points, including *inter alia*: I.) a) certified copy of his APAR from the beginning till the last assessed APAR, b) all other papers, documents, notes, recommendations from his CR-dossier, in addition to his ACRs and APARs, c) cover(envelope) of the CR-dossier and II.) a duly signed list of all the documents, mentioning the document and page numbers being provided to him.

2. The appellant filed a second appeal before the Commission on the grounds that incomplete and incorrect information had been provided by the PIO, which was subsequently upheld and affirmed by the FAA. The appellant requested the Commission to direct respondent to furnish information sought by him.

**Hearing:**

3. The appellant Mr. Shashi Kant was present through video conferencing. The respondent Mr. N Vijayragavan, CPIO, BARC could be contacted through video conferencing after some lapse of time, on account of change of venue of video conferencing.

4. The appellant reiterated that he is not satisfied with the response of the respondent as complete documents as sought for vide his RTI application dated 30.06.2017 has not been furnished to him.

5. The respondent submitted that copies of APARs for the period 01.08.1984 to 30.06.2010 had been provided, receipt whereof had been duly acknowledged by the appellant vide a communication dated 18.01.2011. Copies of the appellant's APAR for the period between 01.07.2014 to 30.06.2015 had also been provided to him vide letter dated 28.07.2017, excluding the portion of his Self Appraisal. Copies of the appellant's APAR for the period 01.07.2010 to 30.06.2014, contained in 39 pages, excluding his self appraisal, was also provided to the appellant vide PIO's reply dated 03.08.2017.

**Decision:**

6. The Commission, after hearing the submissions of both the parties and perusing the records, observes that copies of the APARs for most of the period

i.e. 01.08.1984 to 30.06.2015 have been made available to the appellant. The RTI application is dated 30.06.2017. The Commission, therefore, directs the respondent to provide copies of all the documents which form part of the appellant's APAR for the period 2016-2017, within four weeks of receipt of a copy of this order, under intimation to the Commission.

7. With the above observations, the appeal is disposed of.
8. Copy of the decision be provided free of cost to the parties.
