**ORDER**

1. The appellant filed an online application under the Right to Information Act, 2005 (RTI Act) before the Central Public Information Officer (CPIO), Bhabha Atomic Research Centre (BARC) seeking information on three points pertaining to recruitment and promotion guidelines of DAE for scientific and technical personnel including, inter-alia, (i) the changes in service rules/privileges of a technical officer after undergoing successful completion of specified induction training approved by the competent authority in Department of Atomic Energy (DAE) and considered as Scientific Officer at the time of next promotion in terms of pay & allowances, advance increments, promotion

norms from SO-C to SO-D, promotion norms from SO-D to SO-E, promotion norms from SO-E to SO-F, promotion norms from SO-F to SO-G ; (ii) certified documents by which the following information can be made available about the criteria for dissimilar promotion norms of directly recruited Technical Officers from TO-D to TO-E vis-a-vis trainee scientific officers from SO-D to SO-E having similar job responsibilities and duties ; (iii) criteria for conferring advance increments to trainee scientific officers in DAE after successful completion of their Orientation training program in terms of percentage of marks at training centers or number of trainees etc. at BARC training school, Mumbai and its affiliates in India for (a) three advance increments (b) two advance increments (c) one advance increments.

2. The appellant filed a second appeal before the Commission on the ground that the CPIO failed to furnish correct and complete information to the appellant. The appellant therefore requested the Commission to direct the respondent to provide information sought for by the appellant.

**Hearing: 29.08.2019**

3. The appellant was not present despite notice. The respondent Shri Dr. R. Murgaiya, Chief Administrative Officer, CPIO, BARC attended the hearing through video conferencing.

4. The appellant vide his e-mail dated 27.08.2019 informed the Commission that he does not want to pursue the present second appeal and therefore, requested the Commission to drop the proceedings in respect of his second appeal.

**Decision:**

5. The second appeal is hereby dismissed as 'Withdrawn'.
6. Copy of the decision be provided free of cost to the parties.
