**MINUTES OF THE MEETING OF THE COMPASSIONATE APPOINTMENTS
COMMITTEE(CAC) HELD ON 24/12/2024**

Department of Atomic Energy vide OM No.24/7/2024-SCS/15488 dated 29/10/2024 has modified the system of allocation of relative merit points and has advised to review the compassionate appointment cases not recommended w.e.f 06/05/2022 by applying the revised criteria prescribed in the said OM. The parameters of 'Dependent Family Members' and 'Committed Liability of the deceased Government Servant' has been modified vide the said OM as follows:

- i) The condition to consider 'only the first two children or 3rd child or more in case of 2nd birth resulting in multiple births has been removed and there is no cap on the number of children as dependents.
- ii) Loans taken by the deceased employee from Banks, Consumer Societies, Employees Co-operative Societies and housing loans (irrespective of number of houses) may be taken into consideration. The loans/liabilities taken into consideration will be subject to verification, proper certification and documentation from banks, Consumer Societies and Employees Co-operative Societies. The loans/liabilities of deceased employees were taken into account on the basis of documentary proof provided by the applicant and loans availed from BARC Employees Co-operative Societies has been substantiated by the BARC Employees Co-operative society.

2 Consequent to the above changes and in order to review all the recommended cases of Compassionate Appointment in the meeting held after 06.05.2022, a meeting of the Compassionate Appointments Committee was held on 24/12/2024 in BARC, Trombay, Mumbai – 400085.

Administrative Officer-III, AERB could not attend the meeting. Shri Rajnish Bhaskar Joshi, Senior Accounts Officer attended the meeting in place of Deputy Controller of Accounts, BARC. Smt.Sumitra Bhawe, SO/E, MSW attended the meeting as an Invitee.

3. The Committee reviewed 30 non recommended applications for Compassionate Appointment received from the family members of the deceased employees of Bhabha Atomic Research Centre in accordance with said OM. As per the Relative Merit Point on 100 point scale formulated by DAE, applicants scoring points 50% and above will be prima-facie treated as eligible for consideration for Compassionate Appointment, subject to availability of vacancies. However, depending upon the number of vacancies, persons having more points may be considered as per the said DAE OM.

4. The Committee evaluated the information furnished by the Applicants in the Application for compassionate appointment Form which was verified by Medical Social Welfare Officer and the information available in Administration and Accounts Section related to deceased Government Servants.

Servant, and in case it is proved subsequently that the family members are being neglected or are not being maintained by him/her properly, his/her appointment will be liable to be terminated forthwith.
