As regards Sr. No. 16 and 17, the Committee did not assess the cases, since the applications have been submitted after a long gap of death of the Government servant. The scheme for Compassionate Appointment very clearly states that the concept of Compassionate Appointment is largely related to the need for immediate assistance to the family of the Government servant in order to relieve it from economic distress. Both the cases seem to be defeating the very purpose of Compassionate Appointment. The very fact that the family has been able to manage somehow all these years is adequate proof that the family had some dependable means of subsistence.
